VOLUNTARY CONTRIBUTIONS

You may contribute to the Plan (through payroll deduction). The minimum contribution is 1% of pay and the maximum is 100% of your salary not to exceed \$18,000 a year. Employees who are age 50 or older may contribute an additional \$6,000 for a total of \$24,000.

PRE-TAX OR ROTH CONTRIBUTIONS

Employees can designate their personal contributions as a Pre-Tax and/or Roth designation

- Traditional/Pre-Tax Contributions
 - o Contributions are excluded from income for the year(s) in which they are made
 - o On withdrawal Contributions and earnings are taxable as income.
- Designated Roth Contributions
 - o After tax contributions are included in income for the year(s) in which they are made.
 - On withdrawal Federal-income-tax-free as long as the five-year rule is satisfied, and a participant is age 59 ½ or older, becomes disabled or dies. If these conditions are not met, earnings, but not contributions, are taxable as withdrawn.

ROLLOVER CONTRIBUTIONS

Other retirement accounts can be consolidated into this Plan

INVESTMENT OPTIONS

TERMINATION OF EMPLOYMENT OR RETIREMENT
